Describe:

There was no package failure. Consignee's storage tank overflowed while the carrier was unloading the CTMV. The carrier immediately stopped unloading, however, the storage tank continued to overflow. Released hazmat was contained in the consignee's storage tank containment structure, mitigating the impact of the release.

Investigation revealed that the CTMV was connected to the wrong consignee pipeline. The unloading area has two nearly identical, unmarked pipes that lead to two different product storage tanks. The heats of solution and neutralization of the resultant mixture appears to have caused the storage tank to boil over for about two hours.
