MATERIAL WAS RECOVERED WITH A SUMP PUMP AND THE AREA WAS WASHED DOWN WITH WATER. THEY ALSO USED ABSORBENT SHEETS FOR APPRX. 5-10 GALLONS OF MATERIAL. THE RECOVERED WASTE WAS SENT TO THE S/K FACILITY IN LEXINGTON SC. FOR PROCESSING.
