Driver transferring product from refined fuel trailer into a liquid bulk storage facility. Storage facility had no guages, therefore the driver overfilled the 4000 gallon tank at the facility. Product was contained and absorbed at the facility. The estimated duration of the release was 3-4 minutes. The contaminated dirt was removed and replaced per Kansas Department of Health and Environment recommendation. Per Kansas Department of Health and Environment, the soil was farmed at the location.
