Describe:

A pick up truck pulled out in front of a motorhome forcing the motorhome into the bobtail hauling propane. The impact caused the bobtail to overturn and catch fire in the front portion of the cab where there was diesel spill. The heat from the fire caused the cargo tank relief valve to open and release minimal amount of propane. The relief valve reseated itself.

The diesel spill was cleaned up and the propane that released dissipated in air.
