DSR dropped tank on dock and release valve broke resulting in release of liquid helium gas. Chemtrec was contacted and per their request dock was evacuated until vapor had been completely released. Duration of release was approximately 1 hour. After release, tank was set upright to mitigate release and moved to a separate location on dock away from primary personnel.
