Describe:

According to the information obtained the following occurred. The tractor-tanker unit was involved in a single vehicle accident as a result of an undetermined cause. As a result of the accident, the tanker was damaged resulting in a release of approximately 6600 gallons of free liquid. The free liquid impacted a roadside ditch. Environmental Management, Inc. was dispatched to perform the cleanup. Environmental Management, Inc. arrived and completed a site assessment. Environmental Management, Inc. determined that most of the free liquids were contained to a 30 x 40 foot area. Environmental Management, Inc. deployed absorbent material as needed. Republic Carriers personnel recovered the remaining liquids from the tanker. Environmental Management, Inc. excavated the contaminated soil from the impacted area.
