DRIVER HAD JUST MADE A LEFT HAND TURN WHEN THE TRUCK WENT OFF THE EDGE OF THE ROAD. DRIVER THEN ATTEMPTED TO BRING THE TRUCK BACK INTO THE ROAD WHEN THE MOMENTUM OF THE LIQUID AND THE SLOPING ROAD SIDE CAUSED THE TRUCK TO OVERTURN. THE DRIVER THEN CALLED "911" AND THE LOCAL FIRE, POLICE AND A HAZARDOUS MATERIAL RESPONSE TEAM RESPONDED. THE SPILLED LIQUID WAS PICKED UP AND THE SITE IS CURRENTLY BEING CLEANED UP. THE REASON FOR THE TRUCK GOING OFF THE ROAD HAD NOT BEEN DETERMINED. ALL DRIVER HAVE BEEN GIVENN A COPY OF A DOT NOTICE TITLES ON GUARD "WHICH TALKS ABOUT LIQUIDS SHIFTING AND CAUSING OVERTURNS"
