DRIVER WAS SOUTHBOUND ON HWY 59. HE WAS IN THE PROCESS OF MAKING A LEFT TURN ONTO EDWARDS RD AND UPSET UNIT ON RIGHT SIDE. THE CAUSE WAS EXCESSIVE SPEED FOR CONDITIONS. WHEN DRIVER HAD LOADED AT WRIGHT WYOMING, HE DID NOT TIGHTEN THE DOME LID TIGHT AND WHEN TRAILER UPSET PRODUCT LEAKED OUT OF DOME LID. DYNOL NOBEL PERSONNEL WAS ON SITE WITHIN 15 MINUTES AND TIGHTENED DOWN LID AND STOPPED LEAKING. THE REMAINING PRODUCT WAS TRANSFERRED TO ANOTHER UNIT AND THE SPILLED PRODUCT WAS VACUUMED UP AND REUSED. APPROXIMATELY 2 TO 3 YARDS OF DIRT WAS EXCAVATED AND DISPOSED OF. IF DRIVER HAD TIGHTENED DOWN THE DOME LID, NO PRODUCT WOULD HAVE LEAKED.
