Describe:

As CO2 was transferred from the storage receiver through the fill hose to the vehicle cargo tank, the fill hose ruptured allowing CO2 to be released. Employee left area and contacted 911 emergency personnel (local fire department) who incorrectly identified product as propane and ordered an evacuation of the surrounding area. When the county hazmat team arrived, they correctly identified the product as CO2 and went through the building to confirm there were no life-safety hazards.
