AS TRAILER WAS PRESSURIZED FOR UNLOADING - TRAILER BEGAN TO LEAK SUMP AREA OF TRAILER. THE CUSTOMER PLANT BROUGHT IN EARTH TO CONTAIN THE SPILL. PRODUCT WAS UNLOADED WITH A PORTABLE AIR PUMP. DURING THE OPERATION, A FITTING BROOKED SPRAYING PRODUCT ONTO THE CONTAINMENT AREA WALL. REPLACEMENT OF FITTING ON THE PORTABLE PUMP STOPPED THE PROBLEM AND THE TRAILER WAS COMPLETELY UNLOADED. AN OUTSIDE CLEANUP RESPONSE COMPANY WAS CALLED IN-SUPERIOR ENVIRONMENTAL (PHONE 800-688-4005). THERE WERE NO INJURIES AND THERE WAS NO ENTRY OF PRODUCT INTO ANY WATERWAYS.
