DRIVER HOOKED UP HOSE TO UNLOAD, PRODUCT WOULD NOT COME OUT OF TANKER. DRIVER OPENED EXTERNAL VALVE, PRODUCT WAS FROZEN IN THE UNLOAD LINE. DRIVER TOOK EXTERNAL VALVE APART AND PUT STEAM HOSE UP INTO THE LINE TO THAW PRODUCT. WHEN PRODUCT FINALLY THAWED OUT THERE WAS NO EXTERNAL VALVE ASSEMBLY TO STOP FLOW, SO THE ENTIRE LOAD WENT ONTO THE GROUND. PRODUCT WAS CONTAINED ON THE ASPHALT PARKING LOT AND IN THE ADJOINING SUMP AREA. PRODUCT WAS CONTAINED ON GENERAL MOTORS PROPERTY AND CLEANED UP BY INLAND WATERS CO, AN ENVIRONMENTAL CLEAN UP COMPANY HIRED BY BULK TRANSPORT. IT WAS LATER DETERMINED THAT A FOREIGN OBJECT IN THE PRODUCT HELD THE INTERNAL VALVE FROM CLOSING. PREVENTION OF FUTURE OCCURRENCES WILL BE ACHIEVED BY VACUUM TESTING ALL INTERNAL VALVES AND RETRAINING DRIVERS TO NEVER DISASSEMBLE VALVES ON FROZEN PRODUCT.
