Describe:

At 1831 EST, Malissa Butzu with Universal Truckload Service contacted ERTS regarding a cargo release. It was reported that due to a single vehicle accident, 13-330 gallon poly totes were ejected from trailer #2066-7770. Contractor advised that after transferring the remainder of the product from the impacted totes to the new totes, only 500 gallons of product did not release. Due to this, this release exceeded the RQ.

Due to there being 13-330 gallons, it is estimated that 3,790 gallons (24,180.6 lbs) of product was lost during the accident. Contractor removed all debris offsite and utilized three roll off boxes to dispose of all soil impacted on the side of the road. The site was backfilled with clean soil and secured with grass seed and straw matting. Absorbent booms have been left in place to be checked after the next rain event. No further cleanup is required.
