AFTER DELIVERY DRIVER MISTAKENLY PULLED THE WRONG VALVE AT A PUMP HOUSE. THE VALVE PULLED WAS TO 2 40000 GALLON UNDERGROUND STORAGE TANKS(UST) THAT FEED FROM A 300000 GALLON ABOVE GROUND STORAGE TANK. THE VALVE ALLOWED FUEL TO FLOW INTO THE UST FILLING THEM TO CAPACITY. FUEL OVERFLOWED THROUGH A VENT PIPE. THE FUEL WAS CONTAINED IN A CONCRETE CONTAINMENT BASIN AND WAS SUBSEQUENTLY RECOVERED IN 55 GALLON DRUMS. THE RESIDUE WAS PROPERLY DISPOSED. THE VALVES ON THE USTS AND THE ABOVE GROUND TANKS HAVE BEEN COLOR CODED TO PREVENT FUTURE MISTAKES. THE DRIVER WAS SUSPENDED FOR TWO DAYS.
