AN O.P.W CAMLOCK FITTING BETWEEN CARGO HOSES CAME UNCOUPLED CAUSING APPRX. 400 TO 500 GALLONS OF CAUSTIC SODA(SODIUM HYDROXIDE) TO BE SPILLED AT PRECISION CAST PARTS. CROSBY AND OVERTON WAS CALLED TO DO THE CLEANUP CROSBY/OVERTON DILUTED PRODUCT AND THE NEUTRALIZED THE CAUSTIC SODA WITH 2 0% MURATIC ACID. THIS SPILL WAS THEN REMOVED AND DISPOSED OF BY THEIR CREW USING THE CLEANUP PROCESS. ONE OF THE CONTRIBUTING FACTORS TO THIS SPILL WAS A FROZEN CHECK VALVE IN THE DELIVERY LINE BELONGING TO PRECISION, PORTLAND OREGON. THE OPW CAMLOCK FITTING CAME LOOSE DUE TO THE BACK PRESSURE CREATED BY THE FROZEN OR STUCK ONE WAY CHECK VALVE IN CUSTOMERS LINE. C
