DRIVER FAILED TO CLOSE INTERNAL OR EXTERNAL VALVE ON TANK, WHICH IN TURN CAUSED PRODUCT TO SPILL OUT OF TANK. DRIVER EVENTUALLY NOTICED SPILL & HIT THE EMERGENCY SHUT-OFF.
