Event was caused by traffic accident that resulted in the release of the product (traffic report with narrative and diagrams attached). The fire department was contacted as the most immediate responders. Clay product was used to contain the spill and prevent any further spread of the product. The cause of the package failure was due to the unit striking the median; at which time three holes were created in the side of the unit. The holes were plugged to prevent any further leakage, the product leaked from the tank for approximately 25 to 30 minutes.
