DRIVER OVER-CORRECTED TRYING TO GET BACK ON THE ROAD, CAUSING THE TRAILER TO ROCK AND ROLL ON IT'S SIDE THE CARGO CONTAINER LOST IT'S LIQUID NITROGEN SHIELD WHICH RESULTED IN THE PRODUCT TO BUILD PRESSURE IN THE VESSEL. THE PRESSURE SAFETY VALVE THEN BLEW, LOSING THE ENTIRE LOAD OF LIQUID HELIUM.
