OUR VEHICLE WAS INVOLVED IN A COLLISION WITH A BRIDGE RESULTING IN PUNCTURE OF CARGO TANK RESULTING IN LOSS OF 3253 GAL. OF SULFURIC ACID. APPROXIMATELY 2500 GALS. WENT INTO DRAINAGE SLOUGH AND THE REST INTO A SMALL CREEK. THE MATERIAL WAS NEUTRALIZED BY SPILTECH, INC. OF LITTLE ROCK, AR AND HAZ-TECH OF TEXARKANA, AR. THE NEUTRALIZED SOIL FROM THE MEDIAN AREA WAS TAKEN TO BENTON, AR LANDFILL. APPROXIMATELY \$3400.00 FOR FISH KILL WAS ASSESSED AT THIS TIME. PHYSICAL INJURY CONSISTED OF 30" X 2" ACID BURN ON ONE INDIVIDUAL'S LEG. THIS PERSON WAS TAKEN TO EMERGENCY ROOM AND TREATED AND RELEASED AFTER ACCIDENT. THIS PERSON WAS A PASSERBY.
