WHITE OIL COMPANY REQUESTED A LOAD OF DYED DIESEL BE TRANSPORTED TO THEIR FACILITY IN ABERDEEN, MS. HOWEVER, THE AMOUNT THEY REQUESTED WAS MORE THAN THEIR ABOVE-GROUND STORAGE TANK COULD CONTAIN. AS REQUESTED CAPITAL TRANSPORT BEGAN FILLING THE TANK AND BECAUSE THE CUSTOMER REQUESTED MORE THAN THE TANK COULD HOLD 1,379 GALLONS OF DYED DIESEL BEGAN FLOWING FROM THE TANK. ACCORDING TO EPA'S SPILL PREVENTION, CONTROL, AND COUNTERMEASURE (SPCC) PROGRAM WHITE OIL COMPANY'S SECONDARY CONTAINMENT SHOULD HAVE HELD THE DIESEL. HOWEVER, THE CONTAINMENT DIKE HAD AN OPENING IN IT AND THE DIESEL WAS RELEASED INTO A NEARBY DITCH. AN EMERGENCY RESPONSE CONTRACTOR WAS CALLED AND THE CLEANED UP THE SPILL. THE SPILL NEVER REACHED A WATER BODY.
