GATE FUEL SERVICE DEPT BROUGHT AIR DRY & BOOMS TO SCENE TO BLOCK OFF ANY ADDITIONAL IMPACT TO DRUMS ON ROAD WAY AND BOOMED OFF DISCHARGE PIPE. JFRD STOPPED FLOW OF DIESEL FROM TRUCK.
