Describe:

The driver was pumping off into customer (Penske) ASTs. The driver had obtained veeder root reading and determined there was room in the tanks for the load to fit prior to unloading. During pump off, the north AST tank overfilled resulting in a spill of est. 700 gallons. Product ran under tanks and moved downhill across the parking lot then left the parking lot and entered bar ditch. The driver shut down pumping process and started containing product spilled. After the fact, it was discovered that veeder root system on tanks was inaccurate. Also, the driver is not responsible for customer piping/valve alignment, when offloading product was only going into the north tank. The tank did not equalize.
