THE DRIVER ARRIVED AT THE CONSIGNEE'S FACILITY TO UNLOAD SODIUM HYDROXIDE AT THAT TIME THE DRIVER PRESENTED THE BILL'S OF LADING TO THE CUSTOMER TO VERIFY. THE PLANT PERSONNEL VERIFIED THAT THE DRIVER WAS DELIVERING THE RIGHT PRODUCT AND THAT THEIR TANK WOULD HOLD THE AMOUNT OF PRODUCT BEING DELIVERED. THE DRIVER STARTED THE UNLOADING PROCESS WHEN A PLANT TECHNICIAN TOLD THE DRIVER HE NEEDED TO SHUT DOWN AS THEIR TANK HAD OVERFLOWED INTO THEIR CONTAINMENT AREA. IT WAS LATER FOUND THAT THE CUSTOMER HAD ORDERED TOO MUCH PRODUCT FOR THAT DELIVERY. THE CUSTOMER TOOK FULL RESPONSIBILITY FOR THE SPILL AND PERFORMED THE PROPER CLEAN UP. THE PRODUCT WAS CONTAINED TO THE CONTAINMENT AREA AROUND THE TANK.
