Describe:

Truck left roadway traveling at 17 MPH onto shoulder and overturned. 911 was called and Colorado State Patrol & Fire Department responded. Rear corner of tractor/truck frame punctured a 6" gash into the shell of tank releasing approx. 210 gallons of petroleum crude oil onto the shoulder of the road. A third-party contractor was called to clean-up the spilled contents.

Describe:

Our driver was cited for careless driving. Our internal incident investigation determined that the truck driver became distracted allowing his truck to drift off of the road and overturning when the driver over-corrected. Gazelle currently has a "No Phone policy" as well as "Distracted Driver training" as part of our on-boarding process. The incident was covered in a company-wide safety meeting. Gazelle is currently researching on-board camera technology.
