BRANDON EATON WAS DRIVING NORTH ON CHERRY ST ROAD TRANSPORTING 2 FULL NH3 TANKS. THE RIGHT REAR WHEEL BEARING FAILED ON THE REAR TANK CAUSING THE TIRE AND RIM TO COME OFF. THE TANKS WHIPPED AS BRANDON SLOWED. THE FRONT TANK WAS PUSHED OVER ON TO THE PAVEMENT BREAKING A FILL VALVE OFF. UNION COUNTY EMERGENCY PERSONNEL AS WELL AS CPS EMPLOYEES RESPONDED. CHERRY ST WAS BLOCKED OFF IN BOTH DIRECTIONS AS THE TANK BLED OFF. AFTER TANK BLED OFF TO BELOW VALVE, THE TANK WAS LIFTED UPRIGHT AND PULLED INTO AN ADJACENT FIELD WHERE REMAINING PRODUCT WAS TRANSFERRED INTO AN EMPTY TANK. THE ENTIRE PROCESS TOOK APPROX. 2 HRS.
