Describe:

Univar driver was making a delivery. When he opened the back of his trailer he had to move a drum off the trailer onto the customer dock in order to get at the customer freight. The driver moved the single drum with a drum dolly and placed it on the customer dock. The driver and unloader noticed a small wet spot on the trailer. The driver noticed that the drum that he had put on the customer dock was leaking. The driver turned the drum on it's side and put it back on the trailer. The customer responded to the leaking drum, cleaning up product and placing material and drum in an overpak. During the clean-up operation the customer evacuated their facility. Four customer employees and one Univar employee were check at the local clinic and released. The drum chime was damaged/cut by some sharp object. It could not be determined when the chime was damaged.
