VI. At 6:12 a.m. on October 14, 2005 Eric Smith from Great Lakes Petroleum Corporation received a call from a driver stating that he had had a spill at a station. Eric then sent a cleanup company over to the site and proceeded to the site himself. When Eric arrived at the site he discovered that the hose had come off the tank during the unloading process spilling product on to the pavement and in to the drains. Inland Waters handled the clean up.
