Prev Spill. Overfilled 20,000 gal AST by 1598 gallons. Product flowed to AST containment dike, but drain valve was open allowing Diesel to flow to oil/water separator which then overflowed to soil. Estimated 600 gallons or less flowed to soil. No surface water impact. Reported to VA DEQ.

Describe:

Eagle's management and safety teams will work with Petroleum Products to seek a better method of delivery to their ASTs that does not rely upon the OPD to alert the driver that the tank is at 90% capacity. We will seek to have PPI order deliveries to specific storage tanks that will hold the entire delivery without concern whether or not the delivery will exceed 90%. This system, although installed with good intent for safety, unfortunately, caused Eagle's drivers to wrongly rely on automatic shutdown to prevent spills rather than for them to gauge and reconcile capacity to prevent overfill.

As a result of this release event, a payroll insert was sent to every driver to reiterate and clarify Eagle's procedures. This will also be the main topic for Eagle's October Safety Meeting. Additionally, Eagle believes that transparency among our employees is a great training tool, therefore, we publicize and post every serious safety event to all Eagle employees and require dialogue among management and employees to affect a culture of prevention.
