Fred Grant, Manager of Terminal Operations, reported a switchman was exposed to denatured alcohol during switching operations in the North Yard in Denver, CO. Mr. Grant stated the alcohol was splashed onto the switchman from a residue tankcar with a loose cap and advised the employee was transported to North Suburban Medical Center in Denver, CO, where he was treated and released. On 11/15/2007 At 09:50 AM, Kim Keeling, Manager of Hazardous Materials, stated the tankcar was interchanged from the Rock Island Railroad and identified the railcar as Tankcar UTLX 205039. Mr. Keeling confirmed tankcar was received with the protective housing closed but not sealed and the liquid valve was open with an unsecured plug. Also, the bottom outlet cap was unsecured (Less than tooltight). State and federal regulatory agencies were notified. At 01:48 PM, Keeling advised the car was secured by a local mechanical employee.
