THE DRIVER ARRIVED A THE PLANT FACILITY AND WAS INSTRUCTED BY THE GUARD THAT SOMEONE WOULD TAKE HIM BACK AND GIVE HIM INSTRUCTIONS ON LOADING AND LOADING PROCEDURES. THE PLANT OPERATOR CAME OUT AND INSTRUCTED THE DRIVER ON PROPER LOADING PROCEDURES AND WAS SHOWING THE DRIVER WHAT WAS REQUIRED. THEY PUT THE LOADING SPOUT INTO THE DOME LID AREA AND PROCEEDED TO START LOADING WHEN THEY REALIZED THAT THE INTERNAL VALVE WAS OPEN AND PRODUCT WAS SPILLING OUT OF THE VALVE IN THE TRAILER. APPROX. 1500 GALS. WAS SPILLED IN THE CONTAINMENT AREA AND WENT INTO THE PLANT REPROCESSING FACILITY WITHIN THE PLANT. PLANT PERSONNEL WASHED DOWN THE CONTAINMENT AND BACK INTO THEIR REPROCESSING OPERATION.
