Train diverted into siding engines through switch and hit parked rail cars holding the hazardous material tearing the body of the hopper car. Called into Dispatching center to make notifications to management personnel, FRA, and NRC and the State Department of Environmental Protection. Contacted ER contractor, and local fire department for assistance. Material was wetted to minimize fire risk and loaded into roll-off boxes pending disposition at permitted treatment facility. Disposal efforts are on-going. Rail was rebuilt to allow the railroad to resume operations.
