ISOLATED INCIDENTS OF UNANTICIPATED BAFFLE FAILURE IN TANK TRAILER. ONE BAFFLE FAILED AT ATTACHMENT POINTS INSIDE TRAILER TANK AND STRUCK THE ADJACENT SAFETY PRESSURE RELIEF VALVE, DAMAGING THE SPRING TENSION AND RETAINING MECHANISM, CAUSING THE VALVE TO LEAK. THIS OCCURRED DURING TRANSPORT; MOST LIKELY WHEN UNIT CAME TO A STOP AT TRUCK STOP PARKING LOT. BY THE TIME A SECOND TRUCK COULD BRING IN A TRAILER TO TRANSFER LOAD 4280 POUNDS OF DIMETHYL ETHER WAS RELEASED IN A GASEOUS STATE OVER A PERIOD OF 6 - 7 HOURS.
