THE PETRO-CHEMICAL TRANSPORT DRIVER WAS MAKING A DELIVERY INTO THE CUSTOMER'S ABOVE GROUND STORAGE TANK. THE ADAPTOR CONNECTING THE HOSE TO THE PUMP CAME LOOSE. THIS ALLOWED THE HOSE TO RELEASE FROM THE PUMP AND SPILL DIESEL FUEL ONTO THE ASPHALT SURFACE. A SMALL PORTION OF THE SPILL WAS ABLE TO RUN OFF OF THE ASPHALT PARKING SURFACE AND IMPACT SOME SOIL. BELFOUR ENVIRONMENTAL RESPONDED TO THE SCENE AND IS HANDLING ALL OF THE ON-GOING REMEDIATION.
