DRIVER ARRIVED AT STATION AND DISCOVERED THAT HE DID NOT HAVE THE RIGHT DOWNSPOUT TO FIT THE UNDER GROUND STORSGE TANK FILL PIPE. HE DECIDED TO USE THE DOWNSPOUT THAT HE HAD. IT FIT THE PIPE BUT WOULDN'T LOCK DOWN. HE UNLOADED HIS FIRST COMPARTMENT WITHOUT INCIDENT AND STATRED ON HIS SECOND COMPARTMENT. HE WENT TO THE CAB OF THE TRUCK TO DO HIS PAPER WORK. HE WAS SITTING IN THE CAB WHEN HE NOTICED THE DOWNSPOUT HAD POPPED OFF OF THE FILL PIPE. HE IMMEDIATELY GOT OPUT AND SHUT DOWN THE EMERGERY VALVE , BUT HE LOST APPROX 500 GALLONS. THIS IS A NEW UST AND THE COMPANY THAT HAD INSTALLED THE TANK HAD SET THE OVERFILL PROTECTION TO SHUT OFF AT 50% INSTEAD OF 90% , AND WHEN IT SHOT OFF IT FORCED THE DOWNSPOUT OFF OF THE FILL SPOUT. THE ALLIANCE FIRE DEPT. RESPONDED AND THE FIRE DEPT. AND CITY OF ALLIANCE CLEANED UP THE SPILL AND DISPOSED OF CONTAMINATED SOIL. THE DRIVER WAS DISCHARGED BECAUSE HE USED THE WRONG DOWNSPORT AND WAS NOT IN ATTENDENCE OF THE UNLOADING.
