UNIT 4104 WAS PARKED FILLING A PROPANE TANK WHEN THE MOTOR FUEL VALVE ON THE CARGO TANK FAILED, RESULTING IN A RELEASE OF PROPANE. IMMEDIATELY THE EMERGENCY SYSTEM WAS SHUT DOWN, AN ATTEMPT WAS MADE TO RE-INSERT THE VALVE; WITHIN SECONDS ALL PILOTS IN THE BUILDING NEARBY WERE TURNED OFF, PEOPLE EVACUATED AND THE FIRE DEPARTMENT CALLED. FIRE DEPARTMENT HOSED TANK FOR APPROX. 20 MINUTES & CLOSED OFF THE STREET UNTIL RELEASE DISPEARED. THE VALVE WAS REMOVED AND PLUGGED. CAUSE IS UNDER INVESTGATION; VALVE IN BEING TESTED.
