Describe:

Tank car BN 875099 staged in a temporary storage track was reported dripping commodity from its bottom outlet valve (BOV) area. A BNSF mechanical responder closed BN 875099's partially open top operated bottom outlet valve's (TOBOV) operating rod by 3/4 turn. In addition, the BOV mounting flange bolts were tool tightened. During the BOV flange bolt securement process, the responder reported that two flange bolts were broken. Afterwards, the leak at the BOV flange connection ceased. The outage in BN 875099 was gauged to estimate the possible commodity loss in transportation. A remediation contractor excavated and removed impacted soils followed by appropriate disposal.
