DRIVER CAME DOWN AN INCLINE ATTEMPTED TO MAKE A LEFT HAND TURN. DRIVER TOOK TURN TOO SHARPLY AND TOO FAST CAUSING TRAILER TO TURN AS LOAD SHIFTED. TRAILER AND TRACTOR LANDED ON ITS SIDE. UPON LANDING PUNCTURE WAS CAUSED IN TWO COMPARTMENTS OF TANKER CAUSING APPROXIMATELY 283 GALLONS OF PRODUCT TO BE RELEASED ONTO THE STREET. IT BEGAN TO RAIN AND THE PRODUCT ENTERED A SEWER DRAIN DURING THE INITIAL CLEANUP. DRIVERS WERE GIVEN ADDITIONAL ACCIDENT SAFETY INSTRUCTIONS AS WELL AS SPEEDING INSTRUCTIONS.
