THE MATERIAL SPILLED IS A DRY POWDER SIMILAR TO CEMENT. SIMILAR TO BULK CEMENT, IT IS TRANSPORTED ON PNEUMATIC TRAILERS. DURING THE UNLOADING A COMPRESSION FITTING IN THE UNLOAD LINE FAILED. THE OPERATOR SHUT THE LINE VALVE UP LINE OF THE FAILURE AND SHUT DOWN THE ONBOARD BLOWER. THE FITTING WAS REPLACED. IN ADDITION, THE FITTING AND ALL SIMILAR FITTINGS ON THIS TRAILER WERE RETRO FITTED WITH ADDITIONAL BRACES TO PREVENT SEPARATION IF THE FITTING FAILS.
