ABSORBENT PADS AND BOOMS AS WELL AS EARTHEN DAMS WERE USED TO CONTAIN THE SPILL. THE CONTAMINANTS WERE VACUUMED UP AND REMEDIATION IS IN PLACE FOR ANY REMAINING CONTAMINATION. PRODUCT REMAINING IN THE TANKER WAS PUMPED OFF AND DELIVERED TO OTHER LOCATIONS.
