TRUCK TRACTOR AND TRAILER GOING WEST ON TEXAS 26 WHEN LIGHT AT HURSTVIEW DR TURNED RED, TWO CARS PROCEEDED INTO THE INTERSECTION, TRUCK AND TRAILER SWERVED TO THE LEFT TO AVOID A COLLISION, ONE CAR WAS STRUCK AND SLIGHTLY DAMAGED THE TRUCK AND TRAILER OVER TURNED ON RIGHT SIDE AND SLID INTO A LIGHT POLE. THE SECOND CAR THEN STRUCK THE TRAILER DOING MINOR DAMAGE THE COMPARTMENTS ON THE TRAILER WERE FRACTURED AND MOST OF THE PRODUCT SPILLED ONTO THE PROVEMENT.
