ON 12/29/14 @ 9:15 AM, OPERATORS WERE REPOSITIONING RAILCARS. HAWKINS SODIUM HYDROXIDE 50% D/C (TILX160898) WAS AT RACK 3. WE NEEDED TO POSITION A BRENNTAG RAILCAR TO LOAD SO OPERATORS DISCONNECTED THE HAWKINS RAILCAR. THE AIR SUPPLY HOSE DROOPED DOWN, SNAGGING THE "TREE" ON TOP OF TILX160898. OPERATOR WAS UNABLE TO STOP THE RAILCAR MOVER OPERATOR IN TIME, AND THE FITTING AND 2" BALL VALVE SNAPPED OFF. THERE WAS NO WAY TO STOP DISCHARGE, SO ROUGHLY 2900 GALLONS OR 37,000 LBS OF SODIUM HYDROXIDE 50% RELEASED FROM THE RAILCAR TO THE GROUND.
