ANOTHER MOTORIST ATTEMPTED TO COMMIT SUICIDE BY GETTING IN PATH OF OUR TRUCK. OUR DRIVER ATTEMPTED TO AVOID THE COLLISION AND A ROLLOVER ACCIDENT OCCURRED. THERE WERE THREE (3) DIFFERENT PRODUCTS ON BOARD-ONLY ONE LEAKED- THE METHYL ETHYL KETONE- TRUCK LEAKED FROM TOP AND BOTTOM OF THAT COMPARTMENT DUE TO COLLISION DAMAGE. CIVIL AUTHORITIES HIRED TWO VACUUM TRUCKS AND HAD ONE RETRIEVE WHAT COULD BE PUMP OUT THE REMAINING TWO (2) COMPARTMENTS. COMBINING ETHANOL AND BUTANOL. THERE WERE NO INJURIES DUE TO PRODUCT, HOWEVER THE DRIVER OF THE OTHER VEHICLE SUSTAINED MAJOR INJURIES FROM THE COLLISION. THERE IS MAJOR ENVIRONMENTAL IMPACT AND A CLEAN UP FIRM FOUR SEASONS ENVIRONMENTAL WAS RETAINED BY THE CIVIL AUTHORITIES TO COMPLETE THE CLEANUP.
