ON JULY 17, 1991 AT 1201, COVERED HOPPER FWD 459569 WAS RAMMED BY ANOTHER RAILCAR IN THE CHICAGO CENTRAL AND PACIFIC RAILROAD'S CEDA RAPIDS YARD. AS A RESULT CAR FWD 459569 OVERTURNED. THE ABOVE PRODUCT THEN CAME OUT THE TOP HATCHCOVERS OF THE COVERED HOPPER. IOWA DEPARTMENT OF NATURAL RESOURCES AND THE LINN COUNTY HEALTH DEPARTMENT NOTIFIED. CEDAR RAPIDS FIRE DEPARTMENT REPONDED ALSO. NO INJURIES. WESTSIDE SALVAGE INC., CALLED AND DOWN CAR TRANSFERRED TO ANOTHER RAILCAR. 26,150 POUNDS OF MATERIAL LOST. APPROX. 95% PICKED UP AS RAILROAD SALVAGE. REMAINDER PRODUCT WAS COVERD WITH CRUSHED LIMESTONE TO NEUTRALIZE IT.
