MS WAS EAST BOUND ON I-20 ON APRIL 19, 1995 AT APPROXIMATELY 1:15AM. TRAVELING APPROXIMATELY 60MPH IN THE NIGHT HAD LANE OF THE INTERSTATE. HE ROUNDED A CURVE AND A DEER STEPPED INTO HIS LANE OF TRAVEL. THE DRIVER SWERVED TO AVOID THE DEER, WENT OFF THE RIGHT SIDE OF THE ROADWAY (INTERSTATED) DOWN AN EMBANKMENT, STRIKING IN TREES. AND LAYING THE TRUCK AND TRAILER OVER ON ITS PASSAGE SIDE CAUSING THE DRUMS TO BE EJECTED OUT THE ROOF OF THE TRAILER-STATE POLICE-ENVIRONMENTAL AGENCIES AND HAZMAT TEAM AND CLEAN UP CREW ON SCENE WITHIN 30 MINUTES TO START THE PROCESS OF CLEANING UP THE SIDE.
