Driver was unloading xylene from trailer to customer tank. He did not realize he had hoses hooked up backwards and overflowed our trailer compartment. Pump and valves were immediately shut off. Driver and customer worked on containing spill. Customer had a load of sand dumped over spill on lot and a vacuum truck to suck up puddles in lot and in street. The puddles contain mostly rain water and some xylene. HazMat Response was called to investigate and clean up lot. Dirt/sand/gravel was removed and new gravel was brought in. Dirt/sand/gravel is being land-farmed at approval of KDHE and water/xylene liquid is being disposed of.
