AT 8:35PM PICK-OFF FOUND A PACKAGE THAT WAS ON FIRE. IMMEDIATELY GRABBED A FIRE EXTINGUISHER AND BEGAN TO TRY TO EXTINGUISH THE FLAMES. DETERMINED COULD NOT PUT OUT THE FIRE AND THE ALARM WAS PULLED AT 8:40PM. THE ADAMS COUNTY FIRE DEPARTMENT RESPONDED AT 8:50PM AND WERE ABLE TO CONTAIN THE FIRE WITH EXTINGUISHERS AND WATER. FIRE WAS CONTAINED AND FIRE DEPARTMENT RELEASED THE BUILDING AT 9:40PM. IT WAS DETERMINED THAT THE PRODUCT HAS LOOSE CAPS AND THAT THE CHEMICAL WAS IGNITED BY A STATIC DISCHARGE.
