VEHICLE WAS TRAVELING EAST BOUND ON HIGHWAY 6 PULLING TWO ANHYDROUS AMMONIA NURSE TANKS AT 25 MPH. THE KING PIN OF THE REAR TANK FAILED AND THE FRONT AXLE WAS PULLED OUT FROM UNDERNEATH THE TANK. THE TANK FELL TO THE HIGHWAY AND ROLLED OVER. IN THE COURSE OF ROLLING OVER THE ROLL CAGE AND VALVES WERE SHEARED FROM THE TANK ALLOWING THE ANHYDROUS TO RELEASE. THE 240 GALLONS OF ANHYDROUS AMMONIA LEAKED FROM THE TANK FOR APPROXIMATELY 6 HOURS FROM THE HOLES LEFT BY THE SHEARED OFF VALVES. RESPONDING FIRE DEPARTMETNTS SPRAYED WATER ONTO THE ESCAPING MIST DURING THE RELEASE TO MITIGATE THE EFFECTS OF THE RELEASE.
