Describe:

According to the information obtained the following occurred. The tractor-tanker unit hit a sink hole, resulting in a roll-over. Approximately 500 gallons of diesel fuel were released from the dome covers of the tanker. The free liquid impacted asphalt and soil. CL Thomas deployed a vacuum truck to recover the free-standing liquid and SWS Environmental was dispatched to perform the initial cleanup. SWS Environmental deployed absorbent material to contain the free liquid on the impacted asphalt surface and prepared the site for excavation on a later date. Mid State Environmental was contracted to complete soil excavation. No injuries or exposures were reported.
