DURING THE UNLOADING PROCESS, A METAL HOSE FITTING ON THE LOADING/UNLOADING PUMP BROKE FOR UNKNOWN REASONS. ABOUT 40,000 POUNDS OF ANHYDROUS AMMONIA WAS RELEASED. THE LOCAL FIRE, POLICE AND HAZARDOUS MATERIALS TEAM WERE NOTIFIED. THE LOCAL EMERGENCY PLANNING COMMISSION, WASHINGTON STATE DEPARTMENT OF ECOLOGY AND THE WASHINGTON STATE DEPARTMENT OF EMERGENCY PLANNING WERE ALSO ON SCENE TO MANAGE THE INCIDENT. A PORTABLE QUANTITY OF ANHYDROUS AMMONIA WAS RELEASED. THE NATIONAL EMERGENCY RESPONSE CENTER WAS NOTIFIED, RESPONSE NUMBER 344349. WE DO NOT KNOW THE CAUSE OF THE HOSE FITTING FAILURE AND HAVE NO RECOMMENDATIONS.
