Driver was unloading diesel and gas at the drop point. Driver hooked up hoses and began the unloading process. Driver went to the tractor and turned around to sight check delivery, when he noticed the hose connected to the second compartment of the delivery tanker on the ground and diesel flowing from discharge valve. Driver shut down unloading and placed spill containment absorbent around discharge area and at the point of least resistance of flow. He also placed absorbent spill pads in and around the spill area.
