THE DRIVER WAS UNABLE TO STOP THE FLOW OF SULFUR AND THE ENTIRE LOAD WAS LOST IN THE CONTAINMENT AREA. EMPLOYEES OF C F INDUSTRIES CLEANED UP THE SULFUR IN THE CONTAINMENT AREA. THE VALVE WAS PULLED OUT OF THE TRAILER AND WAS FOUND TO BE DEFECTIVE. THE VALVE WAS REPAIRED AND THE TRAILER WAS PUT BACK IN SERVICE.
